



During these years, CRIT has established itself as a consolidated group of the University of Barcelona with a recognised research path in local and international projects and collaborating with public and private agents. 
Publications

In 2019 CRIT members have participated in 18 publications, including books, book chapters, articles in academic journals and dissemination articles. Apart from this, some members of CRIT have participated in the Wiley Blackwell encyclopedia of Urban and Regional Studies.

The Wiley-Blackwell Encyclopedia of Urban and Regional Studies

Last year Wiley-Blackwell published the encyclopedia of Urban and Regional studies, which captures the character of complex urban and regional dynamics across the globe, including timely entries on Latin America, Africa, India and China. At the same time, it contains illuminating entries on some of the current concepts that seek to grasp the essence of the global world today, such as those of Friedmann and Sassen on 'global cities'. It also includes discussions of recent economic writings on cities and regions such as those of Richard Florida.

The Wiley Blackwell Encyclopedia of Urban and Regional Studies is an indispensable reference for students and researchers in urban and regional studies, urban sociology, urban geography, and urban anthropology.



Marisol García has co-edited the encyclopedia. She has participated also as author of some entries, together with other CRIT members. Considering that this resource is an invaluable tool for research and study, CRIT has ensured free access to the encyclopedia to all UB community through the on-line library system.





This exhibition reviews the trajectory of the POLIS Research Center of the Universitat de Barcelona -among whose researchers are several members of CRIT- in the Besòs river area (Barcelona). Juliana Marcús (University of Buenos Aires, Argentina) - February

Living city: Disputes for sociocultural production in the city of Buenos Aires. A Dialogue with El Moment de la Ciutadania (Pradel-Miquel and García, 2019)

Dr. Juliana Marcús (UBA) presented the book Ciudad Viva: Disputas por la producción sociocultural del espacio urbano en al Ciudad de Buenos Aires (Buenos Aires: Teseo). This is a collective book editted by Juliana exploring urban conflicts in Buenos Aires around the production of the space. The book analyses dynamics of sociocultural production in Buenos Aires during the last three decades. It departs from a Lefebvre and from sociology of culture.

During the session, we discussed the right to the city comparing the approach with our book *El Momento de la Ciduadanía*.



Lionel Delgado (Universitat de Barcelona) - March

Urban mobility, youth and gender. Urban practices areas and gender resources in the youth population of Barcelona.



Abstract: Urban mobility studies have historically been a field studied by engineers and planners, with a technical and quantitative vision that focused their attention fundamentally on the number of trips, modalities and times, leaving aside a more sociological perspective that would allow understanding how urban mobilities (movements of people, information and objects that form complex socio-technical systems) are constructed materially, symbolically and socially. This study presents the work carried out in the context of the doctoral thesis on the ways in which urban mobilities are

woven from the youth of the city of Barcelona, paying special attention to the gender differential that exists at the time to experience, perceive and practice urban displacements.

Applying a sociological look to an urban reality as fundamental as mobility allows to contribute key elements that enrich the way of understanding the planning of places, urban social conflicts, processes of social exclusion and preferences in terms of displacement, use of spaces public and urban insecurity problems in relation to mobility.

Michael Goldman (University of Minnesota-Twin Cities, USA) - March

Speculative urbanism and the New Volatility of City Life

Abstract: Former UN-Habitat Director Joan Clos declared that we would build more urban infrastructur in the next three decades than in all of human history. He is referring to an emergent global imperative to transform our cities into global (or green or smart) cities, as a necessary path to global sustainability. This range of pressing issues was discussed: Who pays, talk discussed the origins of this global obsession, its uneven transnational spread, and its relationship to the 2008 financial crisis and the current regime of "financializing the city." The talk focused on trends in Europe, the U.S., and in

Indian cities (where Goldman is conducting

research) where new luxury housing and farmer

land dispossession, bankrupt municipalities and global private equity firms as landlords, co-exist. A who uses, and who rebels against such "world-class" infrastructure? How does the making of global cities resolve our most trenchant problems of poverty, inequality, and ecological distress?

Matías Zarlenga (Universidad Tres de Febrero, Argentina) - July

Characterization and taxonomy of independent and self-managed cultural spaces from the City of Buenos Aires



Abstract: The results of a quantitative study carried out in cultural spaces of the city of Buenos Aires were presented. Defined as independent (due to their ideology, poetics and aesthetics independent of state and private logics), self-managed (due to their forms organization and operation) and emerging (due to their recent appearance and proliferation and their novelty in terms of values and forms of management). Within this class of spaces, theatres, live music clubs, cultural centres and milongas were included for the study. From a quantitative approach, based on a survey applied to a probabilistic sample of 161 cultural

spaces in the city (based on a census of 459 spaces), aspects related to the urban location, spatial characteristics, organizational structure were characterized. zational (human resources, management models, economic resources and identity) and the types of programming. Based on the results obtained, a taxonomy was elaborated according to the organizational complexity, the type of programming and the spatial characteristics.

Andrew Wallace (University of Leeds) - October

Post-crash urban and regional dislocation: Brexit and beyond

Abstract: The conditions and future of post-industrial cities and towns have been thrown into fresh turmoil by a spate of populist breakthroughs across the global North. In the UK, this has created severe anxieties about the political, economic and social future of communities alleged to be 'left behind' by global trends. Competing with a toxic nationalist discourse,

one progressive consequence has been fresh interest in models of 'new municipalism', inspired, in part, by post-crash experiments explored in cities like Barcelona. In this presentation, we moved beyond Brexit spaces and pathologies to explore post-crash drivers, conditions and struggles in other European regions.

H2020- CICERONE



The Kick-off meeting of the project took place in February 2019 in Bari (Italy). The consortium started to organised the research and to discuss how to deal with research objectives. The project focuses on the role of global production networks in creative industries and the impact of such networks in local economies. The Barcelona team is researching on fashion design and architecture sectors. During the year, we have developed a preliminary approach to these sectors, analysing to what degree they are part of global production networks. Results of this first approach were discussed in a meeting in Warsaw in June.

The project foresees the 'entrance' to the network through interviews to key companies of the sector which will allow understanding how production is organised, the relevance of local and national factors and how ideas and processes circulate.

Labour insertion of college graduates. Balances and imbalances, employability inequality and gender Project REDICE18-2180

This project, led by CRIT member Joaquín Turmo and with participation of Teresa Bartual, continued with previous research including a multidisciplinary team of 10 researchers of different faculties. The objective of the project was to anlalyse labour insertion of college graduates, their problems and how they approach labour market. Amongst others, the project took into consideration questions like overqualification, salaries, and inequalities linked to gender and academic discipline.

The project finished in 2019 and the results have been presented in international conferences and through research articles (see the section publications for more information)


HAR2017-88672-R Public space, creative participation, civic remembrance. Ministry of Economy and Competitiveness

This Project (2018-2021) led by Antoni Remesar and Sergi Valera, represents the continuity of previous competitive projects focused on the study and analysis of creative participation processes on public space and urban regeneration. The focus of the project is articulated in the monitoring and evaluation of the project "Let's build Bon Pastor's Remembrance" (2014-2018) developed in the Barcelona neighbourhood of the same name.

After the participatory process developed with the neighbors that was reflected in "Let's build the Bon Pastor's Remembrance. Strategic proposal" the work process has entered a phase of co-production by the residents and the Sant Andreu district (Barcelona)

CREASPACE

Within the framework of CREAPOL, a project aimed at researching the new logics of public/collective action for the promotion of creativity, innovation and culture in the territory, CREASPACE is the part of this project whose objective is to analyze the three Ts of the creation spaces: Trajectories, Temporality and Territoriality.
